This contract is made between Valley Kids Therapy and Concrete School District.

Dates of service: 9/1/2024 – 8/31/2025

Occupational and Physical Therapy Evaluation Services

- A. For children without an existing IEP, the Occupational or Physical Therapy staff, whichever is needed, will perform assessments at Valley Kids Therapy (Burlington).
 - a. The caregiver will be provided with and fill out all intake paperwork prior to the assessment.
 - b. The school district will provide information on the child and their special education / therapy needs prior to the evaluation to support documentation.
 - c. Assessments will be charged to Concrete School District:
 - i. This includes all testing materials that Valley Kids will supply.
 - ii. New assessments will be charged \$275 and the report will be sent to Concrete upon completion of evaluation documentation (within 2 weeks of service) to be used in the IEP.
 - iii. For children who need a new IEP (triennial evaluation), there will be a charge of \$200 for the testing. The children will follow the same procedure as needing a new IEP (A) above.
 - iv. For children who need a re-assessment (annual + new goals), there will be a charge of \$200 and a re-evaluation document will be provided.
 - d. The school district or parents/guardians must provide notice of cancellation at least 24 hours in advance.
 - i. If notice of cancellation is not received 24 hours in advance, Concrete SD will be charged \$100.00 "late cancel" fee for missed evaluation appointment.

Physical Therapy Services

- B. For children identified with an existing IEP, the Physical Therapist Personnel will provide treatment at Valley Kids Therapy in Mount Vernon.
 - a. The child will be provided with 1 hour of service every week.
 - b. There will be an established set rate per hour of service.
 - i. Set rate will be \$120 / hour.
 - c. Parents/Guardians must provide notice of cancellation at least 24 hours in advance.
 - i. If notice of cancellation is not received 24 hours in advance, Concrete SD will be charged \$75.00 missed appointment fee.
 - d. The therapist will provide the school district with documentation of therapy services upon request.

Administrative Services

- C. For IEP meetings and other scheduled meetings between Valley Kids and Concrete School District, a fee of \$120 per hour will be charged.


Contract

- D. The contract will begin September 1, 2024 and is valid through August 31, 2025.
 - a. Treatment and assessments may continue throughout the summer months to support IEP goals and objectives.
